The Coosa Youth Leader Award is a District award presented in the same manner as the District Award of Merit. The award is available to Scouts registered as youth to a Troop/Crew/Post within the Coosa District, who render service of an outstanding nature at the **DISTRICT** level. The award is made available annually on the basis of 1 for each 25 traditional units or fraction thereof. The district need not present all the awards to which it is entitled each year.

REQUIREMENTS :

1. Nominee must be a registered Scout (age 14-21).
2. Nominee must have rendered noteworthy service to youth in Scouting and outside Scouting within the Coosa District.
- ***Note: The nature and value of "noteworthy service to youth" may consist of a single plan or decisions that contributed vitally to the lives of large numbers of youth or it may have been given to a small group over an extended period of time.
3. Consideration must be given to the nominee's Scouting position and the corresponding opportunity to render outstanding service beyond the expectations of that Scouting position.
4. The nominee's attitude toward and cooperation with the district and/or council is to be taken into consideration.

PROCEDURE :

1. Annually, district committee will accept nominations from within the Coosa District.
2. The District Committee will vote on nominees
3. Award will be presented at the annual District Banquet.
4. A district and/or council officer should explain the award and its significance.
5. The award may be presented by a former recipient or a District Committee Member.
6. A suitable citation for each recipient should be read indicating what each has done in Scouting.
7. The award certificate may be presented at this time with appropriate congratulations.
8. No uniform insignia accompanies this award.
